Other Treasury Items:

- Steve Brookman suggested donating to Echo Hill & Susan Brookman suggested writing a letter to the Freeholders about how much we appreciate using Echo Hill's facility.
- Kathy Crossin suggested a scholarship for kids who can't afford to attend Camp Carr in the summer.

 Action Board to research this idea before moving forward
- The membership approved a \$100 donation to Camp Carr
- The membership approved \$150 from our race sponsorship budget in 2015 to Girls on the Run
- The Club donated \$50 to St. Hubert's Animal Shelter in honor of Ellen McCaffrey
- There are a number of us who are running the Celebrate Life half-marathon; can the Club match it? The Board reviewed old Meeting minutes and determined that they would donate \$25 for each of the HRH members who are running the race.
- Frederick Slapa suggested that we post a list of the available clothing on the Forum. He also suggested that we look into another vendor where we can have a store open all the time, such as Café Press. There were a few complaints about the style/sizing of the clothing. Frederick volunteered to research other vendors.

Ed proposes a similar budget for 2015 (copy attached)

- Bev questioned why we only have \$124 in advertising revenue for 2014 and 3 advertisers. Action –
 Ed Leydon to investigate this. Follow up Ed investigated this and we received \$184 in advertising revenue.
- Susan suggested an increase in the charitable donation to \$750 because of Ellen McCaffrey this year. The Membership approved this.
- Bev reminded us that there was \$\$ set aside for the John Fischer bench that is probably still there.

Action – Ed Leydon to investigate this. Follow up – There is no separate fund for the bench. Future maintenance will come out of the HRH budget.

Social Chair's report

Celia as outgoing Social Director thanked the Membership and is soliciting the next social director.
