- 1) Upcoming Volunteering Events

 - i) Becca has reached out Dan to determine need for volunteers. They've shortened the course this year and probably need fewer Hunterdon County volunteers. This may result in less 2016 Revenue for the Club.

- 3) Clothing Order

- 4) Marketing:
 - a) New HRH banner flag (suggested by Anna at Annual Meeting). Action Becca will ask Anna to pick this up.
 - b) Flyers Action Becca to update last years, and have copies made.
 - c) Business Cards ordered? Action Ed will order them.
 - d) Magnets Zazzle.com has 3"x4" magnets. We can upload our design and order a bulk of 20 at 3.51/each (plus shipping, but I can probably find a free shipping code), and we can sell to members for \$4 each. Let's ask Steve Brookman to work with the logo to make it fit on the magnet.
